## Is a Federal Shutdown Imminent?

In the last monthly report, I mentioned the possibility of a federal government shutdown to happen October 1. As of this writing (September 29), it is looking like

a probable scenario. In the event of a partial shutdown, some but not all the bills are signed and enacted, and those programs may continue. However, during a full shutdown, no appropriations are available. That means facilities and offices may close, federal workers may not be paid, and other services may go unfulfilled.

Important note: CDs co-located in USDA buildings can be locked out until a new budget is adopted. You may be receiving this report with only have a day before the federal fiscal year, so please be prepared.
